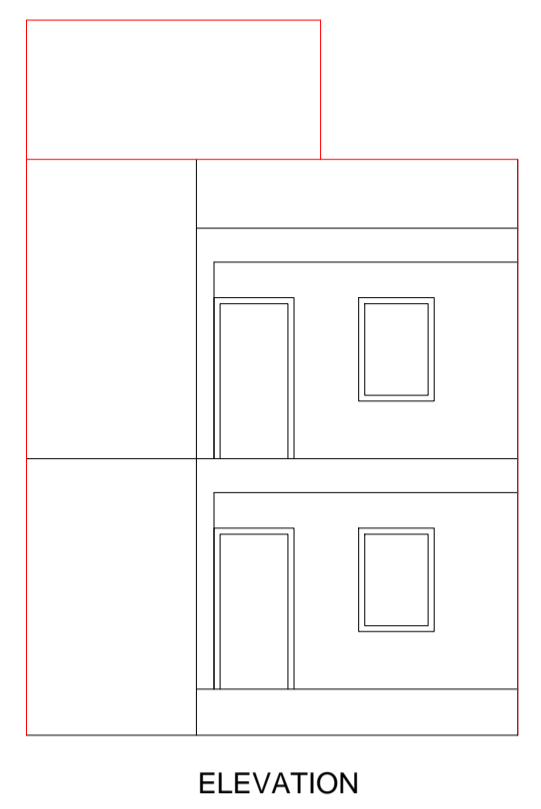
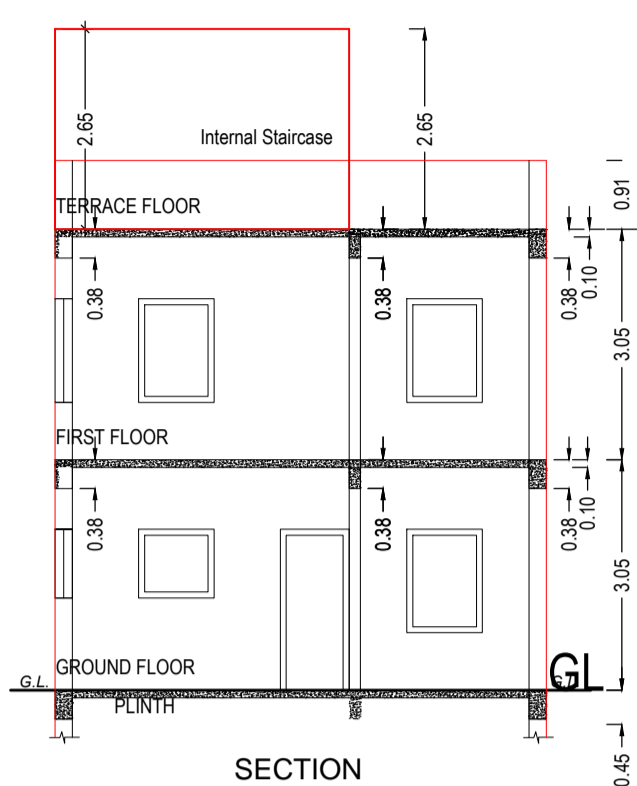


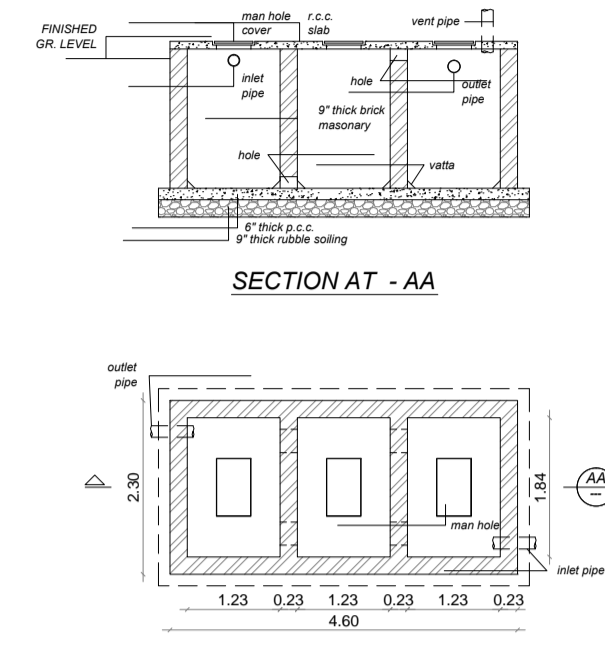
SITE PLAN

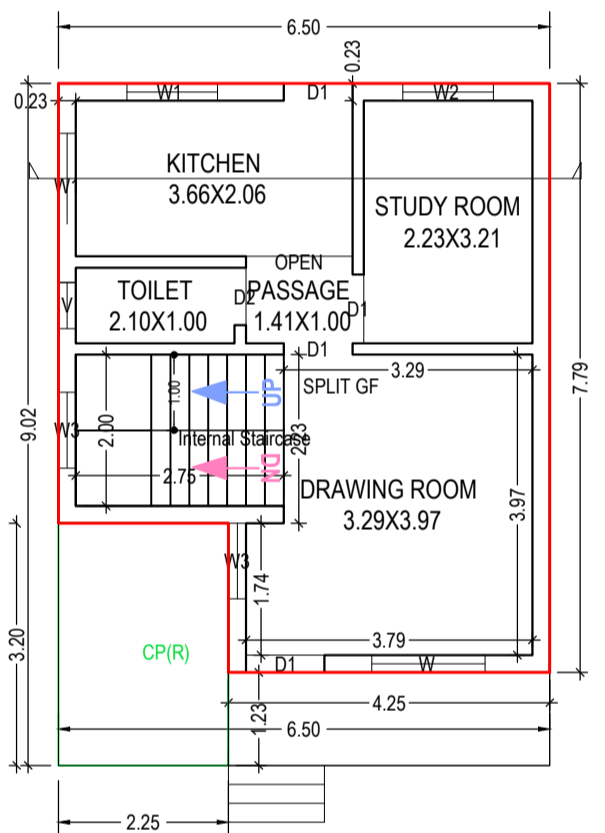

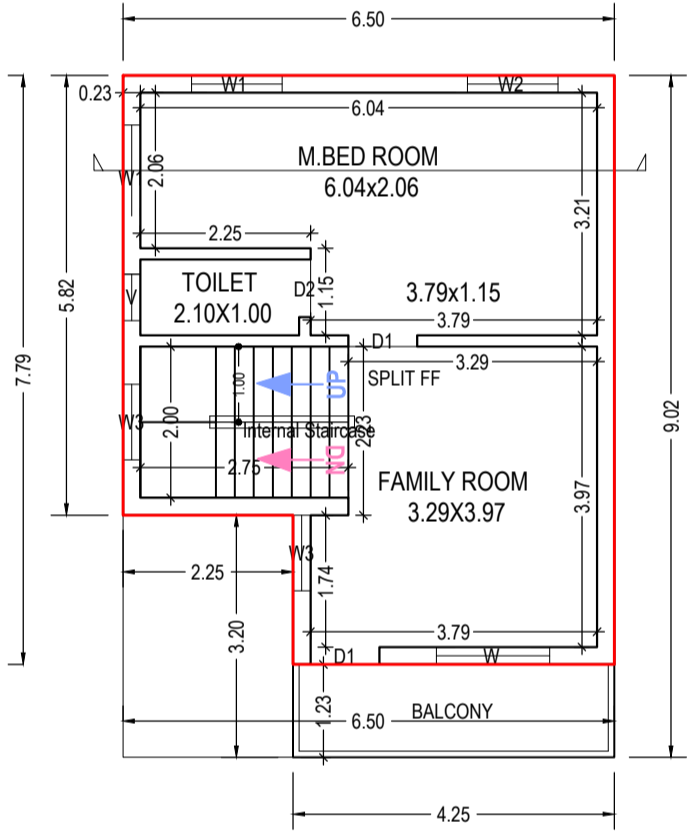

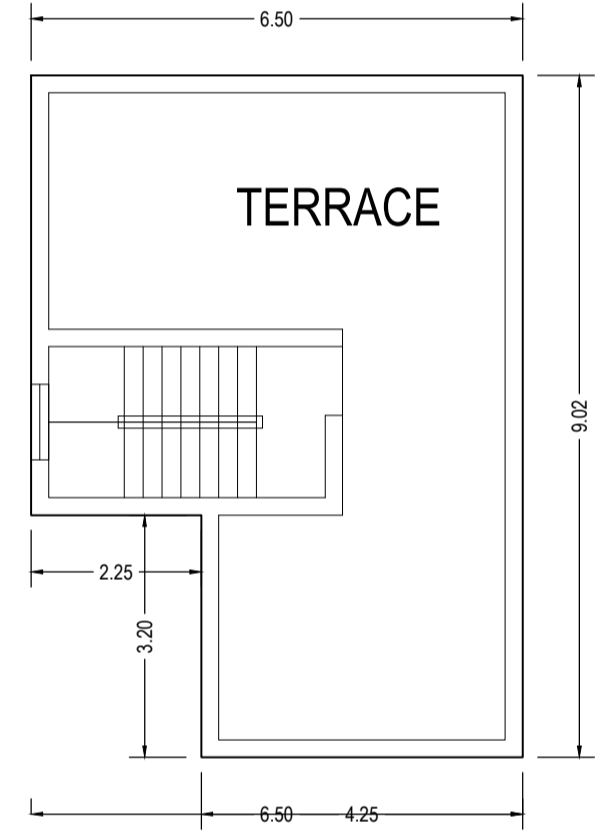
SECTION AT - AA

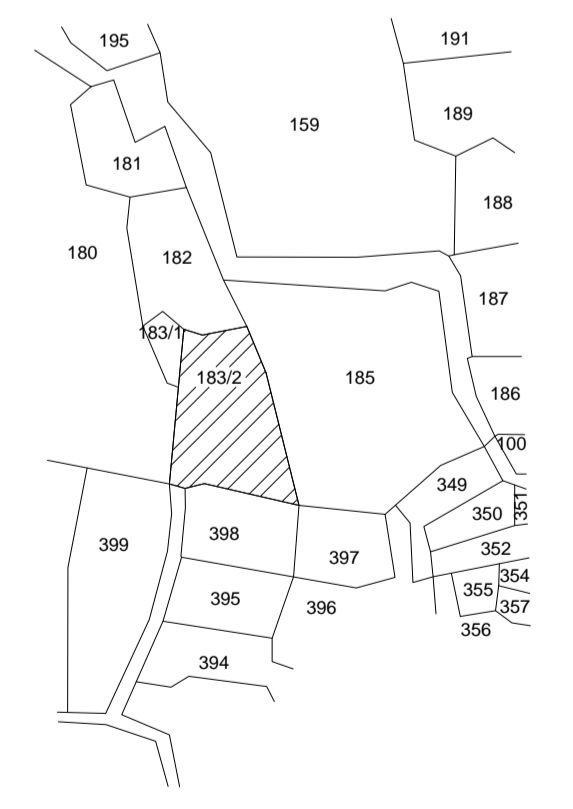
